Honorable Council members,

Management Services respectfully requests the City Council's approval to amend Ordinance Number 6 from the May 8, 2024 City Council meeting. The amendment would authorize the Mayor to trade in four (4) non-ADA compliant buses for three (3) ADA and wheelchair-accessible buses from Don Brown Bus Sales, Inc.

The trade-in buses are as follows:

The new buses are valued at \$136,895.00 each, for a total of \$410,685.00. After accounting for the trade-in value of \$334,800, the city's net cost for the new buses will be \$75,885.00. Funding for this purchase will be allocated from budget codes A7020.203ARP and A7311.203ARP.
