Re: Mount-Vernon City-Hall-Roof Encapsulation - Final Payment (Change Order)

Dear Honorable City Council Members:

On October 17, 2023, this Honorable Body enacted legislation to enter into a contractual agreement with Weather Tight Systems, Inc. for "City Hall Roof Replacement and Repairs" based on the bid received in the amount of \$297,157.00. The goal of this contract was to repair the excessive deterioration of the roofing surface and it's growing inability to provide a dry work environment, ultimately contributing to a detrimental and hazardous working condition for employees of the facility. Particularly those occupying the upper floor right below the previously unaddressed metal surface roof areas.

The Mount Vernon City Hall - Roof, located at 1 Roosevelt Square in Mount Vernon, has three (3) distinct roof surface areas which make up the entirety of the City Hall roof structure. Commonly referred to architecturally as a "Mansard" roof type, which is a multi-sided gambrel-style hip roof characterized by two slopes on each of its sides. The City Hall - Roof has had 2 of 3 of its roof surfaces addressed and satisfactorily repaired. These (2) being the horizontal surface areas making up the top and lower portion of the roof configuration.

Over the years the sloped "Metal" roof areas, or the "3rd" area, were scarcely maintained only occasionally receiving a coat of exterior metal paint, or two. Unfortunately, there also weren't many ways to deal with exterior metal finished roof areas until the last 10-15 years. Partial removal of the horizontal roof surfaces and remedial repairs of the parapet masonry at the roof level, in addition to the installation of a new *Spray Foam Insulating Surface Coating* over the (2) horizontal roof surfaces substantially reduced the water / moisture penetration problems at the lower floor areas.

During construction it was identified that to complete the entire encapsulation of the City Hall Roof by applying Spray Foam Insulating Surface Coating would require additional material installed over the sloped "Metal" roof surfaces which makes up the remaining 3rd portion of the roof configuration. In lieu of the final application of spray foam material being applied to the slope metal roofing areas at that time,

additional repair and prep work was performed at those areas in anticipation of the final Spray Foam application being applied sometime in the foreseeable future.

The additional repairs and temporary patch and prep work has held up considerable and a reduction in water penetration has been noted. In the future when the entire metal roof area is totally encapsulated the roof will provide a moisture resistant barrier which will sub-side interior deterioration due to moisture penetration and will also result in lower energy costs because of the insulating component of the Spray Foam.

This area, which makes up the top portion of the "Building Envelope" is arguably the most important portion of the "Building Envelope" and tremendously affects the ability to keep warm or cold air indoors and more importantly prevents the passage of water and condensation between the exterior and interior of the building.
