Brief Description of Proposed Action: The purpose of this proposed new Code chapter is to promote and protect the property, property values, and health and welfare of the residents of the City of Mount Vernon; guests and visitors to the City; and aesthetic qualities of the environment of the City of Mount Vernon. The City finds that the planting and/or the growing of certain species of bamboo within the City of Mount Vernon has been, and will continue to be, destructive to the natural environment, including indigenous flora; potentially harmful to human health, in that it can provide a breeding ground for mosquitoes which are vectors for disease; destructive to structures, building foundations, walls, driveways, walkways and other improvements on properties within the City adjoining and neighboring those properties where such bamboo has been planted and/or permitted to grow; and that, because of these effects, the City declares it necessary to regulate or prohibit the planting and/or growing of such bamboo within the City.
